RemTech Europe enlarges its horizons with new international experts representing entities, institutions, research centres, associations coming from many countries around the world.

On February 6th, with the coordination of Dr. **Marco Falconi**, present at the headquarter of the Italian Institute for Protection and Research for the Environment ISPRA in Rome, the Scientific Technical Committee of the thematic segment RemTech Europe met in an very participated video conference following the logic of maintaining the most sustainable approach possible.

The coordinator presented to the members the RemTech Expo 2020 new projects and some elements of innovations regarding the next edition. The **Live Demonstration** sessions with presentation of new technologies for investigation and monitoring of environmental matrices will be improved as well as the **Spoken Poster Contest** on the most recent research innovations and the **Discussion Panels** to stimulate interactive debates.

The roundtable brought out the topics selected by the participants for setting up the debates of September, **European Green Deal** and Zero pollution actions, **Environmental Policies**, innovative technologies, PFAS and other emerging contaminants, asbestos, **economical and financial aspects** of remediation activities, **impacts**, case studies.

The call for abstracts will be launched by end February 2020 till May 31st 2020.
